**NOTICE TO CJA PANEL ATTORNEYS REGARDING  
RATES FOR HOURLY COMPENSATION AND MILEAGE**

**I. HOURLY RATE INFORMATION**

Please note the following time frames and rates for submitting your compensation claims for payment:

<u>DATES</u>	<u>COMPENSATION RATES - NON CAPITAL CASES</u>
01/01/00 - 03/31/01	\$70 in court/\$50 out of court
04/01/01 - 04/30/02	\$75 in court/\$55 out of court
05/01/02 - 12/31/05	\$90 for all compensation regardless of type
01/01/06 - 05/19/07	\$92 for all compensation regardless of type
05/20/07 - 12/31/07	\$94 for all compensation regardless of type
01/01/08 - 03/10/09	\$100 for all compensation regardless of type
03/11/09 -	\$110 for all compensation regardless of type

  

<u>DATES</u>	<u>COMPENSATION RATES - CAPITAL CASES</u>
02/01/05 - 12/31/05	\$160 for all compensation
01/01/06 - 05/19/07	\$163 for all compensation
05/20/07 - 12/31/07	\$166 for all compensation
01/01/08 - 03/10/09	\$170 for all compensation
03/11/09 -	\$175 for all compensation

***PLEASE NOTE: You must submit separate vouchers for each different rate period. Failure to do so will result in your voucher being returned to you, unprocessed. Excess compensation claims in non-capital cases require a CJA 26, Supplemental Information Statement for a Compensation Claim in Excess of the Statutory Case Compensation Maximum, explaining the reasons for the excess compensation.***
